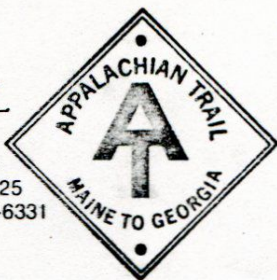

The Appalachian Trail Conference through its member clubs is supporting the HikaNation project as the 50 to 60 participants walk from Damascus to Washington D.C. - leaving the A.T. at Harpers Ferry.

The hike started in San Francisco April 12, 1980 and the unofficial time schedule indicates the group should arrive in Virginia in late February or early March.

Those of you who have followed the hike by reading the AHS Newsletter or Backpacker magazine are aware that along the way much publicity and local participation is the norm.

It is hoped each of our clubs will participate as the group hikes your section of the trail. One point of great importance is that maintenance of the A.T. from Damascus to Harpers Ferry should be even better than during our "Walk Thru" last spring.

It is suggested your club appoint a committee to coordinate club and community activities.

The A.T. as it proceeds northward generally skirts major cities between Damascus and Harpers Ferry; however, Damascus, Pearisburg, Roanoke, Rockfish Gap (Waynesboro) are cities that could be used for welcoming or special activities.

Damascus is certainly one city that is ideal for welcoming because it is the entrance to the famous National Scenic A.T. The hiking community across the nation will have their eyes focused on the A.T. We certainly desire to set an example for the Nations growing Trail system.

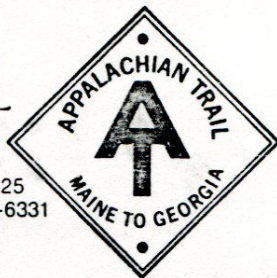

program suitable to their area. No funds have been authorized by the Board of Managers so local activity should be based on self financing.

Reported activities along the hike to date indicate major community and sporting goods company support.

Activities included- and I assume occurred:

1. David F. Hales, Senior Deputy of the Dept. Of Interior met the hikers at Silverton, Colo. Aug. 26.
2. Members of the Youth Conservation Corps (Colo.) joined the hike for several days.
3. Silverton Colo.-welcome hand shakes from Colo. Congressman, a catered dinner, and folk music.
4. Utah-hikers had a chance to go through Zion National Park. The Coleman Co. hosted a breakfast. Special side trip hikes in Utah. The Postum Division of General Foods hosted a beef and chicken barbecue.
5. Some areas- TV coverage.
6. U.S. News and World Report, July 21, 1980 issue.
7. Local residents joined the group for one day to several days.
8. Coverage by UPI, A.P.
9. Greeting by local town officials-mayor.
10. Reese Lukei, Tidewater ATC suggests the Virginia Clubs as a minimum should serve as guides, help plan lodging and assist the group especially if weather is bad. It has also been suggested each club select local laundrymats so clothes can be dried. Location for hot showers and a place to warm up.

The AHS does have state coordinators to assist the hikers in their food supply and other essentials. Reese Lukei is the AHS Virginia coordinator.

The hike from Harpers Ferry to Washington in May, will be under the guidance of Ed Garvey. A huge celebration is scheduled for Washington D.C.

The club planning must be such that dates are flexible. Winter weather will delay the hikers so plans should be completed as soon as possible but can not occur until a few days before the group arrives in your area.

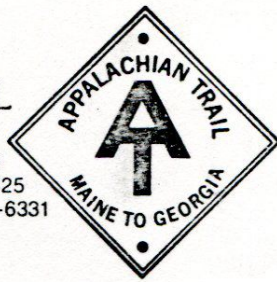
